Who can apply?

We welcome contributions from applicants with social, technical, and multidisciplinary expertise in academia, and the public and private sectors:

- Academic researchers who have previously been funded by PETRAS or the <u>Security</u> of <u>Digital Technologies at the Periphery (SDTaP)</u> programme.
- Academic researchers whose work is closely linked to the PETRAS research topics outlined above.
- Representatives from organisations in the public and private sectors that have been associated with PETRAS or the Security of Digital Technologies at the Periphery (SDTaP) programme.
- Representatives from organisations in the public and private sectors whose work is closely related to the topics of privacy and security of connected technologies outlined in this document.

Types of Exhibition Contributions:

Exhibit stand:

Alongside the programme of talks, we will run an exhibition showcasing the best of PETRAS research, and related work in the public and private sectors.
